## **Description of necessary first aid measures**

# Specific hazards arising from the chemical

: Highly flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. ### **Precautions for safe handling**

# Appropriate engineering controls

: Use only with adequate ventilation.
